The Worshipful Company of Fruiterers has awarded Ian Mitchell, Chairman of the Bramley Apple Campaign Group, with the prestigious Lewis Award for services to the marketing of

Ian Mitchell received his award from the Master of the Fruiterers Company, Tony Redsell at the Annual Livery Banquet held at the Plaisterers Hall, London on Thursday 5 February.

The Lewis Award is held in high esteem within the fruit industry and is only awarded once every three years.

Making the award, the Master, Tony Redsell said: "This award recognises the very considerable success of the Bramley Group in

bringing this particular English variety to the forefront of recognition by leading retailers, multiples and the consumer".

"When the Bramley Campaign started, the variety was under threat of delisting by some major multiples. Now, Bramleys are regarded as a "must-stock" item, with events such as the annual Bramley Apple Week, stimulating increased sales of up to 80 per cent in major retailers".

"One of the key objectives of the campaign has been to position Bramley as a premium product, delivering good returns to growers. Analysis of wholesale prices over the past five years, shows that prices have risen by an average of 15 per cent in real terms and demand for new Bramley trees for planting is outstripping supply, as growers become aware of the real business potential now offered by the variety" said Tony Redsell.

The Bramley Campaign has invested £2.25 million in promotion since 1989 and, because they concentrated on a very strong promotional and public relations campaign through Nexus Public Relations, they achieved an advertising equivalent of around £16 million, promoting Bramleys, since the campaign first started. Bramley Week in the first week of February and Bramley Apple Pie Sunday, on the first Sunday in October have become an integral part of English Top Fruit promotion, year to year.

"The long term aim of the campaign has been to win acceptance with consumers, food

opinion writers and retailers that Bramley is the culinary apple and this has been noticeably achieved through the leadership and farsightedness of lan Mitchell, the Chairman of the Bramley Group. The English top fruit industry is very proud of him and his achievements" said Tony Redsell.

lan Mitchell graduated from Wye College with a degree in Agriculture and after working in Chile he returned to join his Father and Uncle in their already established fruit business in Kent and their marketing business in Covent Garden. Later he developed a specialisation in Bramley Apples and their all year round storage. The Fruiterers Company Lewis Award recognises his achievement in creating the right environment for profitable Bramley production.

### THE FIRST OF OUR STRATEGIC MANAGEMENT COURSES SUCCESSFULLY COMPLETED AT WYE

The first six day residential course sponsored jointly by the Company and the Fresh Produce Consortium was held at Wye College in March. It was led by Professor David Hughes, Sainsbury Professor of Agribusiness and Food Marketing at the College which is part of the University of London. David Hughes is a liveryman of the Company.

This course, which is intended to be repeated, is the first of a number of initiatives launched last year by the Awards Council and was able to be funded from contributions made by Liverymen following the appeal for renewal or commencement of a programme of covenanted support.

The new course offered a concentrated week of business management training and development.

The broad mix of business interests of those participating, from growers to wholesalers, importers to marketing cooperatives, proved highly beneficial, as did the insight into modern management techniques, trends in the industry, and how to gain competitive advantage. More specifically the course examined such developments as EU enlargement, food safety and efficient consumer response.

"Excellent - well worth the time" and "I am now able to look at my business more strategically" were just two of the comments received





### THE BEADLE'S MACE AND STAFF

In 1981 our Company was presented with this Mace and Staff, our benefactor was the late Mrs Richard Gothard the wife of Past Master "Dickie" Gothard who was for many years Archivist to our Livery Company.

The Beadle's Mace and Staff is a most beautiful and functional object, a jewellers work of art, the head is represented in the form of a burnished Gilt apple (engraved with the Company Coat of Arms) which is encompassed with a forest of apple branches. Regrettably the previous Mace and Staff dating back to (1748) was stolen in 1980 and this gift replaced it.



### OUR PLACE IN THE PAST RECORDER

According to the history of the Company written by Arthur Gould in 1912 the last Hall occupied as their own by the Fruiterers Company was in Worcester House. It was on the Thames, to the west of what is now Southwark Bridge. The Company occupied it between about 1587 and 1623, when they began to use the Parish Clerks' Hall. After they left the Fruiterers continued to maintain very strong links with that area of the north foreshore of the river. They had a warehouse there and the lane running down to it was known as "Fruiterers' Alley" in the mid 18th Century.

In about 1980 the Company sought to commemorate its association with site where Worcester House once stood. A plaque was placed on the wall of a building in Worcester Place. Unfortunately the plaque occupied the site for only half the length of time the Fruiterers had occupied Worcester House. In 1996 the building it was on was demolished, to be replaced by an imaginative, boldly modern office building, designed by Kohn Pendersen Fox Associates, to be known as Thames Court.

The developers, Markborough Properties Limited, are keenly aware of the significance of their site to the City's heritage and when contacted by the Company were enthusiastic about replacing the old plaque with a new one in bronze. It will be formally unveiled by the Master on the 16th April, 375 years after the Company gave up its lease on Worcester House.

The plaque will be located at the corner of Thames Court nearest Southwark Bridge, on the new north bank walkway being created by the City Corporation. From there, there is a splendid view of the newly constructed Globe Theatre, the original of which would have been thriving at exactly the time our ancestor Fruiterers would have been in occupation of Worcester House.

The walkway is planned to run from the Tower to Westminster. It is not yet complete. Close by Thames Court will be a passage under Southwark Bridge. The City Engineer's Office have provisionally agreed that it will be named to mark the Fruiterers Company's connection with the area, perhaps Fruiterers' Passage or Fruiterers' Alley.

### THE UK FOOD STANDARDS AGENCY

The UK Food Standards Agency came closer to becoming a reality when Agriculture Minister Jeff Rooker and Health Department Minister Tessa Jowell addressed a meeting of food industry representatives in London early in November. Establishment of the Agency fulfills Government manifesto promises, and underlines the current administration's view that protection of public health and nutritional quality of food are of paramount importance in agriculture.

A Government White Paper outlining the establishment of the Agency is expected in December, with legislation late in 1998, but Ministers were able to provide several clear pointers to its probable organisation and operation. Key is the marked shift in emphasis and support towards consumers and away from producers. According to Jeff Rooker, the Agency will mark a "radical change in the machinery of government" in its comprehensive powers, its involvement "at every level, plough-to-plate", and in the transparency of its decision-making processes. Heavy reliance will be placed on independent specialist advisory committees, representative but avoiding food industry biases and "not a conduit for lobbies of any sort".

Much of the manpower and funding for the new Agency, together with enhanced levels of inspection and enforcement, will be derived from MAFF resources and within current budget constraints, with obvious impact on other areas of MAFF involvement. Though responsibility is still under debate, Tessa Jowell seemed in no doubt that the Agency would report to Health Ministers.

#### DINNER WITH THE MASTER

The Master and Wardens have started to hold a series of informal dinners, each with about nine or ten members of the Livery. It is planned to hold about one a month in an appropriate venue such as the Inner Temple or the Farmers Club. The Master hopes that the dinners will have a number of benefits, apart from just being another opportunity to pass time in good company.

He hopes that it will give the Livery generally a chance to get to know the Master and Wardens and to learn what the Company's plans are for the future. He would also very much like it to be a two way process in which the Livery can express its views as to where the Livery is going and what it might be doing in the years to come.

The first two dinners have already happened and another is planned for early May, but dining as regularly as they can it will take the Master and Wardens a time to get round the entire Livery, at which point it will have to be decided if the dinners are to become a regular feature of Company life. The dinners so far have been very successful and the Master and Wardens are committed to holding them for the foreseeable future.

### ATHELHAMPTON HOUSE GARDENS WIN THE 1998 PRIZE

The Garden of the year award, sponsored jointly by The Historical Houses Association and Christies, has been won by Athelhampton House in Dorset.

The house is the home of Patrick Cooke, son of the late Jenny du Cann and was visited by the Company in 1997 where a tree planting took place in her memory.

The Master and the Clerk have been invited to the prizegiving on April 30th, and the Company is delighted with the ongoing connection with this prestigious award.

A conundrum as to planting a tree or trees at a venue which the Company has already visited has been overcome by the decision to plant a single tree this time. This will be done on April 30th and there will not be a second livery visit on this occasion.

Patrick and his sister Louise will be invited to our Summer Court Dinner in July.

### ALVERSTOKE FLORAL DECORATION SOCIETY

The above society is entering the NAFAS competition at the Chelsea Flower Show in May. The subject title which has been set as their task is "Worshipful Companies" and after research they have selected The Fruiterers Company as the guild which they wish to interpret. They intend to adopt our colours (Green and White) and prepare their design in appropriate plant material.

They have many ideas, one being to include the basket of fruit which we present to The Lord Mayor in the design.

The Master will be visiting the Show and will be making a special visit to this Society. We hope they are successful, and that we can include a photograph of the exhibit in our next issue.
